2. Price bid opening date will be intimated separately.
3. Revised scope of work.

1. SCOPE OF THE CONTRACTOR

- 1.1. Familiarization of ship and ship equipment's.
- 1.2. PPEs shall be in the scope of Contractor (Helmet, Safety shoe, Boiler Suits are mandatory)
- 1.3. Crew insurance shall be in the scope of Contractor for the entire duration.
- 1.4. No of days required - **10 Days (Maximum)**
- 1.5. Tentative Crew requirement shall be **03 Nov 2023**.
- 1.6. Exact crew requirement date will be intimated in one week advance.
- 1.7. Ensuring the safe handling of the vessel, coordination with the agents/pilots for port entry and exit, during operation.
- 1.8. Crew to be positioned onboard vessel during bollard pull trials, according to the requirements and port clearance during BP trials at NMPT.
- 1.9. Crew will be allowed to stay onboard during the above-mentioned BP trials, if required.
- 1.10. Crew will not be allowed to stay onboard, until and unless specified, during the vessel positioned at UCSSL premises.
- 1.11. Crew to man the vessel during, built trial, official sea trials and BP trials.
- 1.12. COC of the planned crew to be submitted within 03 days of awarding of the contract and the same will be used by shipyard for obtaining sea trail permission.
- 1.13. The COC document submitted for the crew to be valid and true in nature. An undertaking of the same to be submitted.
- 1.14. Identity proof of the manning crew should also be submitted along with the COC




SCOPE OF UCSL
