- 3.5. Applying one coats of Primers and two coats of enamel paints on the surface of purlins /rafters/steel structures as per the specifications given by the UCSL.
- 6.1. Necessary Scaffolding / Manlift as required for movement of man and materials to the roof is to be arranged by the contractor.

**READ AS:**

- 3.5. Applying one coats of Primers and two coats of enamel paints on the surface of purlins /rafters/steel structures at height will be under contractor scope and the paint application at ground level and supply of paints for entire scope will be under UCSL.
- 6.1. Necessary Scaffolding / Manlift as required for movement of man and materials to the roof is to be arranged by the contractor, if required as per site conditions. UCSL will provide the service of crane/hydra for the scope of works, as per availability.

40% contract value payment will be released on supply of the all materials as per BOQ, at UCSL-Malpe yard and on the basis of certification by UCSL-Civil QA/QC regarding the acceptance of the supplied materials at UCSL.

**STAGE-II:**

Balance 60% payment will be released after satisfactory completion & commissioning of the entire work and acceptance by UCSL.

**READ AS:**

12.1. Payment will be done in two (02) stages:

**STAGE-I:**

70% supply of the materials as per BOQ, at UCSL-Malpe yard and on the basis of certification by UCSL-Civil QA/QC regarding the acceptance of the supplied materials at UCSL.

**STAGE-II:**

Balance 30% of the supply value and 100% of installation charges will be released after satisfactory completion & commissioning of the entire work and acceptance by UCSL.
