

SUBJECT: RENEWAL OF RAINWATER GUTTER AT UCSL. HANGARAKATTE YARD.

- A. The following changes have been made to the above-mentioned tender.
- 1. Description of work (Clause No:1) in Annexure-I
- 1.1. Renewal of the existing rainwater gutter system between Bay 2 & 3, CS Bay side and Bay 1 at UCSL, Hangarkatte Yard. The scope includes dismantling the existing gutter, fabricating and installing a new Galvalume gutter, and reconnecting the drainage system. Approximate length and dimension of gutter is as mentioned below.

2. Following works have been added to the Scope of work, Under clause No: 5 in Annexure-I.

i. Clause No:5.1 in Dismantling

- Prior to dismantling the existing gutter, the vendor shall carry out a detailed inspection
 of the gutter and the associated roof area. Any damaged roof sheets identified during the
 inspection shall be reported to the UCSL In-charge. The vendor shall quote separate rate
 for the supply of roof sheets along with the tender. The cost for removal and refixation of
 roof sheets required for execution of the new gutter shall be included in the quoted rate
 for gutter renewal.
- Specification of new sheet to be supplied: Pre-coated galvalume sheets of trapezoidal 5corrugation, 0.50 mm total coated thickness. The sheets shall have a protective.

ii. Clause No:5.2 in Fabrication & Installation

- Both ends of gutter shall be closed properly to prevent leakage and the other end of the gutter to be connected to the existing funnel arrangement for water drain.
- The gutter shall be provided with the required slope, as per site conditions, to ensure smooth flow of rainwater and to prevent water stagnation.

iii. Clause No:5.3 in Drain Arrangement

- Provide 5-inch diameter drain holes at every 1.4-meter interval along the gutter length.
- Necessary slope to be provided for the existing two 8-inch horizontal UPVC drain pipe to ensure proper water flow.

iv. Clause No:5.4 in Other Conditions.

• The payment shall be for the actual work carried out.

v. Clause No:5.5 in Flashing sheet Renewal.

• The existing flashing sheet in bay 4 side (near the Plate Yard Gantry Crane) has corroded, resulting in water ingress into the shed. The damaged flashing sheet shall be removed. A new flashing sheet of approximately 500 mm width, 38 m length, and 2 mm thickness shall be fabricated with necessary bending and installed in position to ensure proper sealing and prevention of water leakage.
