1. Please refer Vacancy Notification No. UCSL/IMS/HR/VN-F/11- DET/2025/59\_dated 19 November 2025 for selection to the post of Diploma Engineering Trainees for Udupi Cochin Shipyard Limited (UCSL) published on UCSL website ([www.udupicsl.com](http://www.udupicsl.com))
2. As per clause F of the above referred vacancy notification, the method of selection shall be through Phase I - Objective Type Online Test & Phase II - Writing Skills Test. Further details are available in the vacancy notification.
3. The Objective Type Online test and Descriptive (Writing Skills) offline test for the post shall be held Mangalore and Udupi centers in Karnataka on **12 January 2026 (Monday) from 1400 hrs to 1615 hrs (Reporting time 1230 hrs)**. Venue of examination, test city and other details shall be intimated to the candidates separately in the call letter. Candidates shall attend the Objective Type Online test and Descriptive (Writing Skills) offline test as per the details in the call letter. The Descriptive (Writing Skills) offline test will be conducted immediately after the Objective Type Online test.
4. **Call letters for the test shall be available from 02 January 2026 (Friday) onwards.** The candidates shall be required to **download their call letters from UCSL website (Career page).** All candidates can download their call letter by Login. All test related instructions shall be detailed in the call letter. Candidates are to abide by all the instructions in the call letter.
5. **Candidates appearing for the test should produce two copies of the Call Letter and a valid photo identity proof (in original). ONLY Aadhaar/ Election ID Card/ Passport/ Driving License issued by the Government shall be accepted as photo identity proof to appear for the Objective Type Online test. Those who do not produce the call letter and valid photo identity proof (in original) will not be allowed to appear for the Objective Type Online test.**
6. Candidates should **paste recent passport size photographs** and put their signature in appropriate places in both the copies of the call letter.
7. **One copy of the call letter is to be submitted to the invigilator at the time of the Online test. The candidates should retain the other copy of the call letter till the**

**completion of selection process.**

8. **A link for doing mock test will be available on UCSL website.** This is to familiarize the candidates on the pattern of the Online test and **all candidates are advised to take time for completing the mock test before appearing for the Online test.** The candidates may please note that the contents of the mock test may have no resemblance with the original Online test.
9. **Candidates should ensure that they fulfill all the eligibility requirements viz. age, qualification, caste, disability etc., as advertised before appearing for the Objective Type Online test.**
10. **Candidates need not carry with them any Original Certificates or mark sheets or their photocopies to the Online test centers.**
11. **Candidature is provisional subject to verification of certificates for proof of age, qualification, experience, caste, disability etc. and meeting the notified eligibility requirements, at the time of certificate verification/joining.** If the candidates shortlisted are found not meeting the eligibility requirements or fail to produce certificates in original or if at any stage, it is found that any information furnished by the candidate is false/ incorrect, or there has been suppression of facts and information, the candidate shall not be considered for selection and candidature/appointment will be cancelled/rejected without further notice.
12. **No correspondence regarding the rejection of application in case of ineligibility during the selection process or at any other stage shall be entertained.**
13. **Candidates are advised to frequently visit UCSL website (Career page) for all updates related to the selection process.**
14. Any changes in the above schedule shall be notified on UCSL websites only.
